

Terms & Conditions

(MUST BE READ BEFORE SIGN-IN ON MATCHDAY)

If you want to play paintball/airsoft skirmishing at '1066 Paintball & Airsoft Centre' and engage in the activity you must understand and agree with all of the statements below:-

You understand that the game itself and skirmishing may be physically and mentally demanding, may require extreme exertion to play, that the terrain may be hazardous and furthermore it can be dangerous if not played in accordance with the stated rules which you will read, hear and understand and that the possibility of injury, to yourself and others does exist, including bruises and broken skin from the ammunition provided and/or the playing environment.

You will wear safety goggles at all times when outside the safe zones during play.

You confirm and agree that you are fully aware of the risks to yourself and others involved in paintball/airsoft skirmishing activities at 1066 Paintball & Airsoft Centre and that you will never, under any circumstances deliberately shoot any person in the face or head.

You confirm that you are physically fit and mentally able to withstand the potential strains and exertions required for playing paintball/airsoft.

You agree to comply with '1066 Paintball & Airsoft Centre' rules and to use the equipment only as instructed and for the purpose intended and not in anyway that could deliberately injure, hurt or jeopardise the safety of others. You will obey all directions and instructions of the supervisory and administrative staff.

You explicitly release, remise and forever discharge from any claims and liabilities whatsoever without limitations that you might have against the owners of '1066 Paintball & Airsoft Centre', the owners of the property and land on which the game is played or against any other player partaking in the game who may injure any player howsoever rising, along with any loss or damage to personal property.

You understand that all media content (photographic and/or videographic) remains the intellectual property of 1066 Paintball & Airsoft Centre and may only be used for personal purposes at the business' discretion, and is strictly precluded from any commercial use whatsoever in any context deemed inappropriate by the business owners and staff.

You agree to hire, for the duration of the playing time, such equipment as is deemed necessary by the owners and staff of '1066 Paintball & Airsoft Centre' and agree to return said items at the end of that game. You understand that you will be charged NOT LESS THAN THE COST OF REPLACEMENT of any items not returned at the end of the day.
